



Dear Intrawest Resort Homeowner,

As a member of Intrawest Resort family, we would like to offer you the convenience of direct deposit for your monthly homeowner payments. Included in this letter you will find an authorization form allowing the automatic deposit of monthly rental income to savings or checking account of your choice.

If you are interested in using this feature, please be sure to attach either a voided check for checking accounts or a deposit slip for savings accounts with your completed form. Each door to the hall will receive separate deposits. If you own more than one condo, we ask that you include separate direct deposit forms with attached voided check/deposit slip for each individual unit. No more than one condo per form. For example if you own unit 320/321/323 you only need to return one direct deposit form however if you own unit 243 and 653 you need to return two direct deposit forms.

Payments will automatically be deposited for each accounting period. Direct deposits will be processed on the same day statements are mailed. The statement format and detail will remain the same and you will continue to receive statements in the mail for your records. Please note that the transition will require at least one full accounting cycle before your first direct deposit is made. For example, if we receive the authorization form before the close of the December accounting period (Dec. 31, 2008), your first direct deposit will coordinate with the February accounting period and correlating statement mailed in January.

We trust that this feature will offer a new level of convenience for you and rest assured that the information provided will remain confidential and secure within our Lodging Accounting department. If at any time you wish to add, change or terminate the direct deposit feature or have any further questions or concerns, please contact the Homeowner Relations office at your respective resort or simply fax completed documentation to 970.870.3165 with attention to your specific resort and we will process accordingly.
